

# 203 SPRAY CONTACT ADHESIVE PREMIUM GRADE



## DESCRIPTION:

**203 SPRAY CONTACT ADHESIVE** is a premium grade spray contact adhesive. Offering high heat resistance, and good open time, 203 CONTACT ADHESIVE bonds a wide range of materials including decorative plastic laminates, fabric, cloth backed and polyester backed vinyl, MDF and particleboard, timber, metal, concrete, glass, rubber and urethane foam.

## USES:

- Decorative laminates for cabinet making and shopfitting applications
- Auto upholstery and furniture upholstery

## SURFACE PREPARATION:

Surfaces to be bonded should be clean and free from oil, dust, loose and other foreign materials. Metal surfaces should be degreased with TAC 101 CONTACT CLEANER

## APPLICATION:

- Coverage rate, evaporation time, open time and press time are dependent on type of materials to be bonded as well as workshop conditions such as temperature and humidity
- Do not use below 10°C as condensed water may form on the adhesive film and prevent bonding.
- Best results are obtained under the following conditions:
  - Workshop, material and glue temperature: 20°C
  - Wood moisture: 8 - 10%
  - Relative humidity: 60 - 70%
- Apply adhesive evenly to both surfaces with spray gun
- Allow adhesive to evaporate until it is no longer tacky to touch
- Join surfaces before end of open time
- Apply as much pressure as possible to obtain optimum bond strength

6 - 8 m<sup>2</sup>/Litre

## DRYING TIMES:

- Evaporation Time @ 20°C: 5 - 10 minutes
- Open Time @ 20°C: 10 - 15 minutes

## CLEAN UP:

Use TAC 101 CONTACT CLEANER

## SHELF LIFE/STORAGE:

- Store under cover, out of direct sunlight and in a well ventilated area
- Keep away from all sources of ignition
- Shelf life is 12 months when stored as per above recommendations
